Publication Ethics and Malpractice Statement

The Editorial Board of the journal *Police and Security* respects and adheres to high ethical and scientific standards in publishing. The document is available online:

The Editorial Board accepts or rejects papers for publication in the journal exclusively based on the journal's standards, the manuscript's intellectual merit and the relevance of its topic to the scope of the journal, regardless of the author's race, gender, citizenship, ethnic origin, religious beliefs, or political preferences.

The Editor-in-Chief and the Editorial Board have an obligation towards the authors to maintain the integrity and confidentiality of the author's work during the evaluation of the work for publication.

The Editor-in-Chief is responsible for the work of the Editorial Board, for finding competent and qualified reviewers, and for the dynamics, ensuring that the review process is implemented correctly and on time.

The review procedure includes two or more reviews of one author's article. The reviews are double-blind, which means that the communication between the reviewers and the author takes place via the Editor-in-Chief or the Editorial Board; that is, the Editor-in-Chief and the Editorial Board do not reveal the identity of either the author or the reviewer during the review process.

The Editor-in-Chief may reject an article without external review if he considers that the submitted article's topic is outside the journal's scope, if the article is of poor quality, or if it does not meet the requirements for manuscript submission. The Editor-in-Chief can consult with the members of the Editorial Board about the selection of reviewers for an individual article.

Reviewers are obliged to inform the Editor-in-Chief of any potential conflict of interest in relation to the article submitted for review. Reviewers should evaluate the manuscript with responsibility, objectivity and constructiveness. They should also inform the Editor-in-Chief if they are not sufficiently qualified for the topic of the article to be evaluated.

Reviewers are obliged to protect the integrity and authorship of the article entrusted to them for review, and they are not allowed to show the text and materials to other people or to use them in their publications and research before the article is published. With their advice, the reviewers help the author improve the quality of the article, and the Editor-in-Chief and the Editorial Board in the categorization, i.e. in the impartial evaluation of the scientific and professional content of the article. In case of disagreement in the assessment of two reviewers, the Editorial Board can seek the opinion of a third reviewer, and the final decision on acceptance of the article for publication and on categorization, based on the reviewers' assessments, is made by the Editor-in-Chief.

Manuscripts must be free from plagiarism, and authors should avoid unacceptable forms of conduct within the academic community.

If suspicion is raised about the originality of the manuscript, the Editorial Board may check the manuscript for plagiarism. This also includes cases of insufficient citations where the author does not give the reader enough information to understand what information is from a source and what is original.

Authors should avoid appropriating other people's results, views or opinions as their own without citing the source. Authors should avoid falsifying or inventing research results, manipulating the process, and intentionally changing or omitting data.

When creating papers, authors must respect the plurality of ideas and opinions, avoid hate speech or discrimination on any basis, and avoid conflicts of interest in any form.

If the authors use someone else's knowledge, they should state and cite them appropriately. They are obliged to obtain permission to print images, documents, etc., from the respective copyright holders.

Authors should mention the organizations, scientific projects, or institutions that supported the research published in the author's article.

Authors cannot submit a text that has already been published or a manuscript that they have simultaneously submitted for evaluation to another journal.

By submitting articles for publication in the journal *Police and Security*, the authors agree to have their articles displayed in *PDF* format on the Ministry of the Interior and Hřčak websites.
